

Order no. 1/2022
of the Dean of the Faculty of Social Sciences of 5 January 2022
concerning organisation of teaching at the Faculty of Social Sciences
from 10 January 2022

Based on §1, §2, §3, §5 and §7 of the Ordinance No. 3/2022 of the Rector of the University of Wrocław of 5 January 2022 concerning forms of teaching at the University of Wrocław in relation to occurrence of the state of epidemic of COVID-19 and §2.1 item 6) of the Ordinance no. 66/2021 of the Rector of the University of Wrocław of 14 May 2021 concerning internal regulative and informative acts at the University of Wrocław and the procedure for issuing the Rector's regulative and informative acts, it is resolved as follows:

§ 1.

1. Lectures for all fields of study, forms and years of study are held **online** through MS Teams platform or the University's e-learning platform. Lectures should be held in a synchronous form at hours provided in the respective schedules.

2. Provisions of § 1.1 **do not concern** lectures that were held **in the traditional form** before introduction of remote teaching as of 13 December 2021.

§ 2.

Classworks, tutorials, seminars and project classes at all fields of studies held at the Faculty of Social Sciences, excluding fields of studies listed in § 3, are held **in the traditional form** in buildings of the University of Wrocław.

§ 3.

In view of prolongation of remote teaching at the Foreign Language Centre of the University of Wrocław until the end of the winter term, classworks, tutorials, seminars and project classes are held **online** for the following years and fields of studies:

- 1) 2nd year of BA studies in Social Policies – all Wednesdays and Fridays;
- 2) 2nd year of BA studies in Sociology of Dispositional Groups – all Wednesdays;
- 3) 3rd year of BA studies in Sociology – all Wednesdays;
- 4) 3rd year of BA studies in Economic Sociology – all Wednesdays and Fridays.

§ 4.

From **10 January 2022 until 6 February 2022**, **remote teaching** is introduced for all **part-time studies** held at the Faculty of Social Sciences.

§ 5.

The Dean may introduce remote teaching for full-time students of the first- or second-cycle studies on terms stipulated in § 3 of the Ordinance No. 37/2021 of the Rector of

the University of Wrocław of 22 March 2021 regarding the rules of functioning of the University of Wrocław in relation to the COVID-19 outbreak exclusively if the reporting infected person was in direct contact with a group or an instructor.

§ 6.

Implementation of this order is the responsibility of directors of institutes and heads of chairs.

§ 7.

Supervision over implementation of this order is the responsibility of the Vice-Dean for Education.

§ 8.

The Order shall come into force on 10 January 2022.
